The head of the World Health Organization says the coronavirus outbreak is accelerating but insists "we can change the trajectory of this pandemic."

State of Ohio

Governor DeWine, Director Acton and others are providing daily press conferences at 2:00pm. The main takeaways from their press briefing will be included below.

DeWine today announced that Director Acton will be signing an amended "Stay at Home" order that extends the date to May 1st. The order will begin on Monday. The new order adds additional provisions to fill gaps where they see people still coming together, including:

- The creation of a dispute resolution panel to address discrepancies in enforcement between political subdivisions
- Retail businesses are required to establish a maximum number of people inside at a time
- People traveling to Ohio will be required to self-quarantine for 14 days, except for those who work in other states or along border areas
- Wedding receptions must follow social distancing rules
- Organized sports are prohibited
- Garden centers are open
- Fishing is allowed, and state parks will not be closed unless people are not following social distancing rules
- State parks will remain open, though if people are too close and can't be separated, the parks director will take action.
- Ohio's school children will remain out of school until at least May 1, at which time the plan would be re-evaluated.
- Dr. Acton Still believes the peak will be in the next few weeks. She reiterated that we need to at least double our hospital capacity to accommodate this surge.
- Bars, salons, barber shops, spas, nail salons, body piercing locations, massage therapy, tanning facilities, tattoo shops and internet cafes are closed. Bureau of Motor Vehicle offices are closed except five across the State. Restaurants will be allowed to operate carryout services.

• Received third SNS shipment. EMA has for distribution.

Ottawa County Health Department

- Ottawa County currently has five positive cases. Three of the five have been hospitalized.
- Patient contact investigations are being done through the Ottawa County Health Department with those having had "close, direct contact", ie, family members, workplace, etc. within the previous 14 day period. This is per ODH guidelines.
- New Ottawa County dashboard will be added to their website.
- Working on public information response with EMA and Magruder Hospital.
- Updated guidance on recreational activities/essential business has been received from the State, who has formed a Dispute Resolution Panel for businesses. Guidance for employers can be found on their Ottawa County Health Department website.
- A suggestion for those organizations providing food is to have the resident open their trunk and the meal/s would be placed into the trunk avoiding face-to-face contact.
- Highly urge conservation of PPE. Reports project COVID-19 to peak mid-May with 10,000 new cases per day.

Ottawa County Emergency Management

- Working with funeral homes and hospital to expedite Death Certificates.
- Our request to the state for medical equipment needed by Magruder Hospital is moving along.

- With Ohio being declared a Major Disaster by the President, this will free up recovery dollars. It is important that you complete and submit the FEMA Request for Public Assistance. Expenses could be recoverable for up to a 75% reimbursement.
- A compiled list of PPE vendors is attached. An order has been placed for face shields and gowns for Magruder Hospital.
- Continue to work on a draft of the guidance from the State on the quarantine, etc. for first responders with the Health Department.
- Have coordinated with Erie and Sandusky County Health Commissioners, Coroners, Sheriff's and EMA Directors to enhance and increase our capacity to handle the deceased.
- Continue to collect PPE and disperse PPE as requested. Putting together information regarding the use and conservation of PPE.
- EMS, hospital, long terms care facilities, law enforcement (jail) in need of PPE are urged to complete the attached form and return it to EMA.
- Digital thermometers are available through EMA, courtesy of OSS Solid Waste District.
- Continue to monitor current events and interface with local agencies as necessary and appropriate.

- Commissioners passed a Resolution for a State of Emergency see OCEMA website.
- Ottawa County EOC activated March 16, 2020 at 1200 hours
- Continue to coordinate the Ottawa County's response to limit spread of COVID-19 and maintain medical care.

Public Information

- Will work on Press Release regarding 14 day quarantine for out of state visitors and campground closures.
- The Ohio Emergency Management Agency (Ohio EMA) is receiving reports of spam calls to Ohioans from individuals claiming to be from the Ohio EMA and requesting personal protected information, such as a Social Security number.
- Public Information Committee has been organized. They are working on community resource links of resources.
- Working on compiling Frequently Asked Questions to post on Magruder Hospital, Ottawa County Health Department and Ottawa County EMA websites.
- Holding regular coordination calls with response partners.
- Making Public Information push with social media and press releases.
- Provide timely, clear, and consistent messaging to the public, stakeholders and media on the status of COVID-19 and actions the public can take to keep themselves safe.

Magruder Hospital:

- If you think you are exhibiting symptoms associated with COVID-19 (fever, cough and shortness of breath), please call your primary care provider. Do not travel to a health facility. Do not go to your nearest emergency room unless it is an emergency situation, then please call the ER first to tell them of your arrival at 419-734-3131 ext. 3602. Only patients meeting certain criteria will be tested. For general questions regarding COVID-19, please call 1.833.4ASKODH (1.833.427.5634).
- Triage line 4/1/2020, 419-301-4304 2 calls
- Respiratory Urgent Care cases will now be redirected to the ED. New process will be Triage hotline nurse will screen patients and if needed, schedule an appointment for them in Urgent Care. These patients will be instructed to park in the ED parking lot and an Urgent Care employee will go to the hallway outside of Urgent Care open the side door.
- Patient Surge Plan Med/Surg, ICU, Surgery will have 36 beds
- Magruder Hospital will collaborate with Firelands Hospital regarding the care of COVID-19 patients. Severe/vented patients will be transferred to Firelands while the non-COVID, minor COVID and surgical patients will be at Magruder Hospital. (Sandusky Register article attached)
- Incident Command is finalizing their Surge Plan. A temporary ward will be ready early next week with 30-40 extra cots available. Thanks to the Ottawa County Inmate Work Program for their help in moving everything out of the Physical Therapy Department.
- Magruder Hospital has received donations of PPE but are still in need. Due to the national shortage of face masks, Magruder Hospital is welcoming fabric masks made by members of our community. According to the Center for Disease Control and Prevention's guidance, fabric masks may be used in a crisis when all other supplies have been exhausted.
- PSI has offered older model vents; RT looked into the vents offered and stated not appropriate for COVID-19 patients.
- Dr. Kerro looking into using anesthesia machines for vents and what would be needed to convert these. We currently have 9 vents plus the portable ones we have.
- Jason K. will develop a letter for employees to keep in case they are pulled over when coming in to work. 419-301-4304
- Visitors prohibited.
- Telemedicine is being set up, some with camera capability. Hopefully up and running by next week.
- Continue to monitor PPE.

Senior Resources

- Weekly meal count is attached.
- Senior Resources is almost at capacity with 300 meals served to area seniors. They will continue to refer to Grab & Go, the Bistro or will take on as able.
- All Home Delivered Meal runs will continue as currently set. Most runs are at capacity but we are adding new eligible clients as we can fit them in.

- All other seniors who may not meet the eligibility requirements are referred grab and go at our senior center's locations (5).
- All seniors who cannot be served by our HDM program are referred to Bistro 163 and the Salvation Army.

Riverview

- Received a referral for a COVID-19 patient that has tested positive from the Henry Ford Hospital in Michigan, which they denied.
- Pending certification Riverview has 17 beds available for less critical patients and Otterbein has ten beds. They have been advised these beds are up for a quick Desk Review.
- Received notification that beginning today all employees will be required to wear face masks.

- All public fares have been waived in effort to reduce the spread of the virus and to help people economically.
- There has been a reduction in service to 6 a.m. 8 p.m. 7 days per week (in county; out-of-county services have not changed)
- Reservation lines have been reduced to 11 a.m. 6 p.m. on Saturdays and Sundays.

Sanitary Engineering

- Staffing rotation to ensure continued operations.
- EPA recommends that Americans continue to use and drink tap water as usual. The presence of the COVID-19 virus has not been detected in drinking-water. Further, EPA's drinking water regulations require treatment at public water systems to remove or kill pathogens, including viruses.
- No shutoffs.

Fire/EMS/Law Enforcement

- Conference call with all departments was held last night, another call will be held Saturday. An email was sent to the Health Department with questions from area departments.
- Dispatch is doing a great job screening calls for symptoms prior to the squad's arrival.
- The Sheriff has asked that law enforcement be notified if they become aware that an offer assisted with a positive test patient.
- UV light boxes for decontamination are available for use at Harris-Elmore Fire Department. Coordinate with Mike McGinnis
- Report of an increase in call reporting flu-like symptoms.
- PPE will become a concern.

- Sheriff's Inmate Work Program is poised to assist Magruder Hospital with set-up of extra bed capacity.
- Ohio Highway State Patrol is available to assist with many needs. Contact EMA if you are in need of their assistance.

Schools

- BENTON-CARROLL-SALEM SCHOOLS: Continues its free meal service for students. All students can get both breakfast and lunch Monday--Friday at no charge. Parents or caregivers may pick-up meals without their child present, but will need to provide the students name and address for verification. The drive through service for all students (including Penta students) will take place at R.C. Waters Elementary School between the hours of 9:00 AM and 12:00 Noon, Monday through Friday. Meals being picked up do not need to be ordered ahead. If you are unable to pick up your child's meal, you may request delivery to your home by calling 419-898-6219. If you need a delivery please call between 8--10 AM. Again, the breakfast and lunch meals will be free for all B-C-S students.
- PORT CLINTON: There will be no meal pick-up Mon, April 6 during Spring Break, however, our dedicated staff will not let our students go hungry. There will be a special meal pick-up on FRIDAY, APRIL 3 2020 at the same locations and times. A Five day meal pack will be given for the week of Spring Break. If you need meals please complete the survey (Look for Final Forms Email; Preschool families survey sent via class dojo). By completing the survey by WED, APRIL 1 we will be able to plan and have the correct number of meals at the appropriate locations. Meal pick-up will resume weekly on Mondays the week following Spring break April 13.
- GENOA AREA LOCAL SCHOOLS: Is distributing to students, breakfast and lunch for the week on Mondays from 11:00 am - 1:00 pm and 3:00 - 5:00 pm. We are distributing from our elementary and from three buses at three different sites throughout the district.
- DANBURY: Is currently distributing meals via pick-up each Monday (1 pick up for 5 days worth of meals). We are providing breakfast and lunch for the entire week. We've been able to provide fresh produce and are serving over 100 meals each work.
- WOODMORE: We are providing 5 days of meals on Mondays. We deliver free and reduced. Non free and reduced can pick them up at either one of our schools.

Municipalities:

- We are hearing a growing number of rumors that the Governor is considering an order closing all parks. This would be extremely unfortunate, but the Governor is doing what he believes is necessary to maintain health and safety.
 - We feel and strongly encourage that this can be handled on a case-by-case basis. However, we are seeing scenes from around the state of large groups congregating in parks. We are certain that if this continues, the Governor will have no choice but to close all parks entirely.
 - <u>We are urging you to do all that you can to make sure that this is not happening in</u> <u>your parks</u>. Posting signs, limiting parking, using rangers/staff to disperse groups of people, removing amenities and even closing high traffic parks are all steps that have been taken by the state and some municipalities. Not only are these the right things to do, but <u>failing to do them may result in a statewide closure of all state</u> <u>and local parks</u>.
- All playground areas (equipment) should be closed at this time as part of the Governor's order. Please consider taping off playgrounds in your jurisdiction.
- There is concern over House Bill 197 restrictions on public water systems. Randy Genzman asks Mayors and Administrators to take a look.
- The State of Ohio passed legislation and Governor DeWine is expected to sign that which will extend state and municipal income tax day to July 15, 2020, and adjust the open meeting policy to permit meetings via electronic means, provided that the public has an opportunity to participate.
- Also included is the suspension of municipal water shut-offs until December 1, 2020, or until the end of the State of Emergency, whichever comes first.
- The amendment includes extending the postponed March 17th primary to April 28, 2020. Voting will commence by mail.



Paycheck Protection Program FAQs for Small Businesses

Where can I apply for the Paycheck Protection Program?

You can apply for the Paycheck Protection Program (PPP) at any lending institution that is approved to participate in the program through the existing U.S. Small Business Administration (SBA) 7(a) lending program and additional lenders approved by the Department of Treasury. This could be the bank you already use, or a nearby bank. There are thousands of banks that already participate in the SBA's lending programs, including numerous community banks. You do not have to visit any government institution to apply for the program. You can call your bank or find SBA-approved lenders in your area through SBA's online <u>Lender Match</u> tool. You can call your local <u>Small Business Development Center</u> or <u>Women's Business Center</u> and they will provide free assistance and guide you to lenders.

Who is eligible for the loan?

You are eligible for a loan if you are a small business that employs 500 employees or fewer, or if your business is in an industry that has an <u>employee-based size standard through SBA</u> that is higher than 500 employees. In addition, if you are a restaurant, hotel, or a business that falls within the North American Industry Classification System (NAICS) code 72, "Accommodation and Food Services," and each of your locations has 500 employees or fewer, you are eligible. Tribal businesses, 501(c)(19) veteran organizations, and 501(c)(3) nonprofits, including religious organizations, will be eligible for the program. Nonprofit organizations are subject to <u>SBA's affiliation standards</u>. Independently owned franchises with under 500 employees, who are approved by SBA, are also eligible. Eligible franchises can be found through <u>SBA's Franchise Directory</u>.

I am an independent contractor or gig economy worker, am I eligible?

Yes. Sole proprietors, independent contractors, gig economy workers, and self-employed individuals are all eligible for the Paycheck Protection Program.

What is the maximum amount I can borrow?

The amount any small business is eligible to borrow is 250 percent of their average monthly payroll expenses, up to a total of \$10 million. This amount is intended to cover 8 weeks of payroll expenses and any additional amounts for making payments towards debt obligations. This 8 week period may be applied to any time frame between February 15, 2020 and June 30, 2020. Seasonal business expenses will be measured using a 12-week period beginning February 15, 2019, or March 1, 2019, whichever the seasonal employer chooses.

How can I use the money such that the loan will be forgiven?

The amount of principal that may be forgiven is equal to the sum of expenses for payroll, and existing interest payments on mortgages, rent payments, leases, and utility service agreements. Payroll costs include employee salaries (up to an annual rate of pay of \$100,000), hourly wages and cash tips, paid sick or medical leave, and group health insurance premiums. If you would like
